This Symposium and Briefing will be held in Washington DC on October 19th (Wednesday), 2011. The Symposium is open to all AERC institution members and visitors, and will be held in the National Museum of the American Indian beginning at 12:00 P.M. (lunch will be provided). The following day, Oct 20th, the AERC will hold its Annual Business Meeting from 9:00 - 12:00 at the Smithsonian's Ripley Center, just off the National Mall. Please note that these days (Wednesday and Thursday) are different than the normal days we hold our meeting (Thursday and Friday) because of venue conflicts this year.

The Symposium (as well as the Congressional Briefing) this year will focus on the benefits that ecosystems provide society. Sometimes referred to as "ecosystem services", the Symposium (and Briefing) will focus on the importance of healthy forests, the role that ecosystems play in reducing nutrient enrichment in aquatic ecosystems, and the importance of healthy ecosystems to our fisheries resources.

Benefits of Ecosystems to Humans in the 21st Century is this year's annual symposium hosted by the Association of Ecosystem Research Centers (AERC). It is scheduled to occur at the Smithsonian National Museum of the American Indian, Washington D.C., on Wednesday, October 19, 2011. The symposium is open to all AERC institution members and visitors, and a lunch will be served in conference rooms 4018 and 4019 at 12:00 p.m. The symposium will begin in the same rooms immediately after lunch. On the following day, October 20, the AERC will host its annual business meeting on the National Mall at the Smithsonian's Ripley Center from 9:00 a.m. – 12:00 p.m. Due to this year's venue conflicts, the symposium and business meeting are scheduled to occur on Wednesday and Thursday rather than Thursday and Friday.

This year's symposium will focus on how ecosystems benefit society. Sometimes referred to as *ecosystem services*, these services provide societal benefits often at very little cost when compared to having to develop, engineer and maintain the infrastructure to provide these services without healthy ecosystems. The symposium will include five presentations by well-known researchers in this arena and end with summaries by representatives of several federal agencies regarding potential funding opportunities in the next twelve months.
